THE MINERAL INDUSTRY OF CONGO (BRAZZAVILLE)

In 2019, the economy of Congo (Brazzaville) was based largely on the production of crude petroleum (Organization of the Petroleum Exporting Countries, 2020, p. 10). The legislative framework for the mineral sector in Congo (Brazzaville) is provided by law No. 4–2005, Decree No. 2007–274, Decree No. 2007–293, law No. 24–1994, and Decree No. 2008–15. Data on mineral production are in table 1. Table 2 is a list of major mineral industry facilities. More-extensive coverage of the mineral industry of Congo (Brazzaville) can be found in previous editions of the U.S. Geological Survey Minerals
